## **1588 Armada conference**

### **(Privacy Statement)**

The Department of Housing, Local Government and Heritage is the Government Department responsible for housing and water, for physical and spatial planning, for local government, for weather forecasting and for built and natural heritage.

The Department is committed to protecting and respecting your privacy. This privacy statement explains how the Department, as the Data Controller, will process the personal data provided to it in respect of registration for, and attendance at, the 1588 Armada conference; how that information will be used, and what rights you may exercise in relation to your personal data.

### **Categories of personal data**

The Department processes the following personal data in respect of registration for, and attendance at, the 1588 Armada conference:

- email address
- first name
- surname
- job title (optional)
- company (optional)
- image (a photographer and videographer will be present to record the event and anyone attending may be on camera).

Note: Attendees at the conference will be informed that photography and video recording will be in use so that they can opt out if they wish. This privacy statement will also be made available to attendees on the day and beforehand on Eventbrite

### **Source of the personal data**

### **Purposes of the processing**

The Department will use the information provided in order to facilitate attendance at the 1588 Armada conference, and to promote the event through photography and filming.

### **Profiling**

The Department will not use any personal data collected from you in respect of the 1588 Armada conference for automated decision-making, or for profiling purposes.

### **Lawfulness of processing**

This processing of your personal data is lawful under Article 6 (1)(e) of the GDPR, which provides that processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller, and Section 168 of the Historic and Archaeological Heritage Miscellaneous Provisions Act 2023.

### **Security of your personal data**

The Department implements appropriate technical and organisational measures to protect your information from unauthorised access. However, despite these efforts, no security measures are perfect or impenetrable, and no method of data transmission can be guaranteed against any interception or other type of misuse. In the event that your personal data is compromised as a result of a breach of security, the Department's Breach Management policy and procedures will be implemented.

### **Recipients of the data**

Personal data may be shared internally for audit or other compliance purposes.

Personal data may be shared with other Government Departments, local authorities, agencies under the aegis of the Department, or other public bodies, in certain circumstances where this is provided for by law.

### **Cross-border Data Transfers**

The Department will not transfer personal data collected in respect of the 1588 Armada conference to any country or international organisation outside the EU/EEA.

### **How long will your data be kept?**

The Department will only retain your personal data for as long as it is necessary for the purposes for which it was collected and processed. In line with legislative and business requirements, the data retention period for your personal data, in this instance, is 1 year after the conclusion of the 1588 Armada conference.

### **Your rights**

The Department's [Data Protection Policy](#), which sets out how we will use your personal data, as well as providing information regarding your rights as a data subject (including details regarding right of access, right to rectification, right to erasure, right to restriction of processing, right to object), is available on our website. If you consider that your rights have been infringed, you have the right to complain to the Irish Data Protection Commission ([www.dataprotection.ie](http://www.dataprotection.ie)), and you have the right to seek a judicial remedy.
